The Ropes ISD Board of Trustees will conduct a public hearing to notify the public of the District's insufficient performance, the improvements in performance expected by the Texas Education Agency, and the interventions and sanctions that may be imposed if the performance does not improve as a result of a Special Accreditation Investigation conducted by the Texas Education Agency's Special Investigations Unit, pursuant to the authority set forth under Texas Education Code §39.057 related to allegations that Ropes ISD was not in compliance with Criminal History Record and Fingerprinting Requirements under Texas Education Code, Chapter 22, Subchapter C. The general public may attend this public hearing, and any member of the public desiring to speak to the Ropes ISD Board will be permitted to do so. The Ropes ISD Board will not limit the number of speakers who may address the Board at this hearing, nor will the Board limit the length of any person's presentation to the Board regarding Ropes ISD's noncompliance with Texas Education Code §§22.0833, 22.0836, and 19 Texas Administrative Code §§153.1109(b)(1) and 153.1111(f)(3).

If during the course of the meeting, discussion of any item on the agenda should be held in a closed meeting, the Board will conduct a closed meeting in accordance with the Texas Open Meetings Act, Government Code, Chapter 551, Subchapters D&E.
